## Automated Invoice Management at Knauf Gips KG

With more than 150 production sites worldwide and 23,000 employees in over 40 countries, the Knauf group with headquarters in Iphofen, Germany is one of the leading producers of building materials. Already in 1998, Knauf Gips KG had introduced an optical archive for digital documents wherein approx. 700 incoming invoices had been stored every day after having been processed.

Today, however, Knauf scans the invoices directly upon receipt, has their contents read and organizes their release via the SAP-integrated FIS/edc® workflow developed by FIS GmbH. The result: faster processing, improved overview, accrual basis and reduction of vendor dunning notices. ## SAP FI and CO at Electrical Wholesaler Sonepar Deutschland

Sonepar Deutschland distributes electrical appliances and installation material of leading national and international suppliers to customers in trade, craft and industry. The company relies on high-quality products and systems with meaningful and groundbreaking services. The accounting of Sonepar, the market leader in the German electrical wholesale, was successfully changed over to SAP. At the end of November 2012, the project ended with a perfect finishing event in Düsseldorf.

Within 20 months, approximately 20 company codes throughout Germany were successfully put into productive use. At peak times, the committed project team consisted of a total of 60 FIS and Sonepar employees.

On April 01, 2012, the first companies went live with SAP, including Sonepar Deutschland/Region Nord-Ost GmbH based in Hannover (second largest opera-

ting company in Germany) as well as Holding Sonepar Deutschland GmbH and the service companies Sonepar Deutschland Financial Services GmbH and Sonepar Deutschland Information Services GmbH.

The changeover ran smoothly. Sonepar's large volume of documents, the interface landscape (approx. 30 interfaces) and complex business processes such as the pooled payment or the National Key Account process represented a major challenge. The entire range of tasks was implemented to the full satisfaction of the customer.

During the second roll-out, the largest German company based in Augsburg as well as the fourth largest company in Nuremberg were connected to the system. This changeover, which took place on July 01, 2012, was perfectly implemented as well. Subsequently, the remaining German companies were changed over to



SAP with the same success on October 01, 2012. Special emphasis is to be placed on the consistently outstanding cooperation between the project teams of Sonepar and FIS. Thanks to the great efforts by all persons involved, the project could be completed successfully.



## Easier Creation of Electronic Balance Sheets with SAP Auxiliaries

Section 5b EStG (Income Tax Act) obliges companies in Germany to electronically submit their balance sheets as well as profit and loss accounts to the fiscal authorities. It includes a general "safe harbor" regulation for fiscal years beginning after December 31, 2012. XBRL (eXtensible Business Reporting Language) is used as transfer format. Fiscal years beginning after December 31, 2012 are to be declared with taxonomy 5.1 (version of June 01, 2012). Elster Rich Client (ERIC) is mandatory for data check and transfer.

SAP ERP supports the process of creating electronic balance sheets by means of the following functions:

- Parallel accounting (account/ledger solution)
- Taxonomy upload function as enhanced balance sheet and profit and loss structure
- Mapping function for operational accounts relative to taxonomy (GAAP)

- Maintenance view for maintaining master data relative to taxonomy (GCD)
- Queries for taxonomy download (GCD and GAAP)

For the further processing of balance sheet data, SAP provides additional modules requiring a license. The SAP Disclosure Management ensures automated processes to accelerate the "last mile of finance" including optional report elements and electronic balance sheets. The application improves the collaboration within the company by means of integrated communication, workflow and approvals across business units. The SAP Disclosure Management enables compliance and control by publishing comprehensible and reliable statements in multiple formats (including the XBRL format for communicating balance sheets to the fiscal authorities).

The SAP ERP Client for electronic balance sheets supports further business proces-

ses concerning electronic balance sheets. Consequently, mandatory specifications from SAP ERP, such as master data, reported financial data as well as proofs of account required for taxonomy can be included in the balance sheet. In a user interface optimally integrated in Microsoft Excel, you can manually add specifications and make the tax reconciliation. The module displays all data in an overview which allows you to control the electronic balance sheet before sending it to the fiscal authorities. So-called NIL values are also clearly visible.

Check and transfer data via ElsterRichClient (ERIC): After the statutory validation of the data via ERIC, the XBRL-based dataset is sent securely to the fiscal authorities. The FIS consultants are experienced in implementing SAP modules for the creation of electronic balance sheets and remain at your disposal for questions or the planning and execution of an electronic balance sheet project.
